Introduction

Law Offices of Maryam M. Golbarg, P.C. ("we" or "us") values its visitors' privacy. This Privacy Policy is effective as of November 20, 2020; it describes how we may collect, protect, use, and share information gathered from or about you, and helps you understand our online information security practices. Consent to this Privacy Policy

By using or accessing this Website you consent to this Privacy Policy and that to be bound by it, including your consent to our use and disclosure of information about you in the manner described herein. This Privacy Policy applies to everyone, including, but not limited to visitors, users and others, who wish to access or use the Website.

Information way may collect and store

It is always up to you whether to disclose personally identifiable information to us, although if you elect not to do so, we reserve the right not to register you as a user or provide you with any products or services. We collect and store your personal identifiable information if you:

- Provide them to us by inputting them into our Website or any other form of communication, including but not limited to, electronic mail, regular mail, and phone calls;

Use of information we collected

 - To outside auditors who have agreed to keep the information confidential;
 - As necessary to enforce our legal notices, other agreements and the Terms of Use;
 - As necessary to protect the rights, safety, or property of Law Offices of Maryam M. Golbarg, P.C., its users, or others. This may include for example exchanging information with other organizations for fraud protection and/or risk reduction.

We may also use the information we collect about you in order to, but not limited to:

- Send a confirmation to you, if necessary;
- Enroll you into programs or services which you are interested;
- Open files and establish accounts, and retain information you send us, via including but not limited to, your correspondence, emails, faxes, or telephone calls, and retain these information in your customer file. We may, over time, delete these records as permitted by law:

Other information we collect and use
